The allotted time for each speaker will be determined according to the number of submittals, with a maximum of 3 minutes per speaker.

### Action Items

Item A. The District will provide a presentation and conduct a Public Hearing on Proposed Parcel Tax

#### Rationale:

The Board will hold a public hearing pursuant to Government Code section 50077 on the issue of calling an election on November 6, 2018, to establish its special tax authority (known as a "Parcel Tax") at the annual rate of \$35.04 on all parcels of taxable real property within the District's boundaries. At the hearing, public input will be solicited concerning the proposed parcel tax measure.

Item B. Trustees will review for possible Action- Resolution No. 01-18 Calling Parcel Tax Election on November 6, 2018

#### Rationale:

Healthcare districts are empowered by Government Code section 53730.01 to seek voter approval to levy a parcel tax on all taxable real property in the District to fund district programs, including operational items and capital improvements. As this Board is aware, the District continues to experience a significant decrease in payments for paramedic ambulance transports. The voters in the District approved Measure AA in 2006 to improve District operations and staffing; however, the

funds raised by Measure AA were not sufficient to fund all the costs to the District to operate paramedic ambulance and other related emergency medical services within the District. Since 2006, the District has been addressing its budget by use of its reserve funds for continued necessary operations, services and capital needs of the District. Without a parcel tax, the District does not and will not have adequate funding to replace aging ambulances and other capital expenditure items, or to repair, maintain and upgrade District facilities.

The resolution directs County officials to place a ballot measure on the November 6, 2018 ballot. The measure, if approved by a 2/3 vote of the electorate, would authorize an ongoing levy of the parcel tax at a rate of \$35.04 on all parcels of taxable real property to provide the best and most efficient emergency medical and paramedic ambulance transport services to the Cambria community by, among other things:

- repairing, replacing, or upgrading its ambulance fleet and related equipment,
- repairing, upgrading and improving its healthcare facilities, and
- recruiting and retaining excellent medical professionals and administrative staff.

The County elections officials require that the resolution be delivered to them by June 18, 2018.
